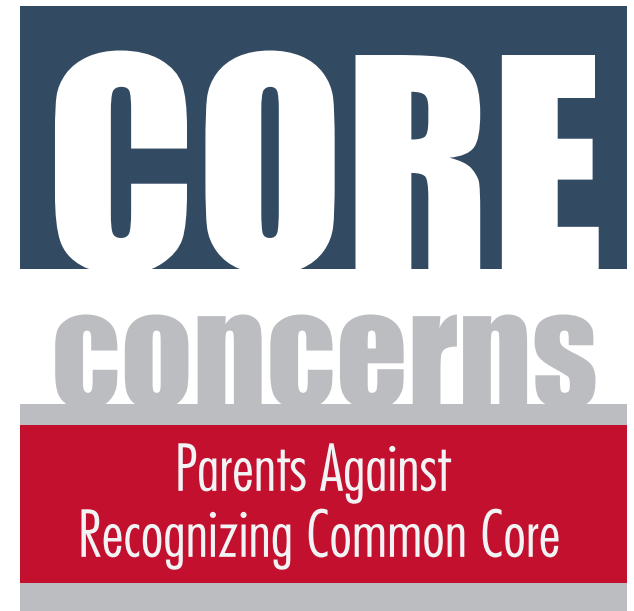
A) *Common Core testing which focuses on content rather than standards will necessitate that all **public schools, charter schools, private schools,** and **home schools** conform to this curriculum.*
